Researchers are now invited to submit abstracts for both oral presentations and poster presentations outlining their research and development associated with the following offshore wind related themes. Every effort will be made to accept quality abstracts that address the identified areas of interest and meet the standards exercised by the Organizing Committee, but submission is

expected to be competitive and authors are encouraged to consider how their contribution may best fit and to ensure that it truly represents the value of their contribution.

## Abstract Format / Authors Instructions:

- Abstracts must be submitted in <u>PDF format</u> by Friday, September 13<sup>th</sup>, 2024 using the following links:

- Abstracts must be prepared using the provided template and guidelines.
- Submitted abstracts will be peer reviewed by experts in the field who have been selected by the Organizing Committee.
- Authors will be informed of acceptance of their extended abstract by September 20<sup>th</sup>, 2024 and any associated peer review comments will be forwarded to the author.

- Abstract submission deadline: September 13, 2024
- Peer Review Period: September 13 September 19<sup>th</sup>, 2024
- Author notification of acceptance: by September 20, 2024
- Presentations: November 18, 2024

## **Presentation Formats**

## Oral Presentations

Sessions are 60 minutes in length and will have 3-4 speakers. Each speaker will have 12-15 minutes for their presentation. A 10-15 minute question and answer period will conclude the session following all of the presentations. Only one speaker per abstract will be allowed to participate in the presentation and will be acknowledged in the Forum Program. Co-authors can be listed in the speaker's PowerPoint presentation.

## Poster Presentations

Poster presentations will be displayed in the exhibition hall throughout the duration of the R&D Forum. The poster session provides an excellent opportunity for authors and forum attends to discuss interesting, innovative work or to discuss ongoing research. Authors will be limited to a maximum of two (2) posters in this year's poster session.
